Operations Airport Safety Standards Program sets forth the rules and regulations for safe in the Airport at Hartsfield-Jackson Atlanta International Airport.

All corrective training for Class I, Class II or Class III violations must be completed within 7 business days of the issuance of a Notice of Violation (NOV) or the SIDA badge will be deactivated. All corrective training and Airport driving suspensions for Class I, Class II or Class III violations must be completed before any Airport driving privileges are reinstated.



### **Class 1 Sanctions**

- Violators must view the SMS module and the Non-Movement Area Driving module and pass each test
- 1 point



# **Class 2 Sanctions**

- Violators must view the SMS module and Non-Movement Area Driving module and pass each test
- An immediate 2-day suspension of all Airport driving privileges
- 2 points



## **Class 3 Sanctions**

- Violators must view the SMS module and Non-Movement Area Driving module and pass each test
- An immediate 7-day suspension of all Airport driving privileges
- 3 points
